ABC News reports on a court case in which Mississippi parents are taking a stand against inequity in the state school system. Their claim is that for years Mississippi has amended the state constitution to continue to deprive Black students of their education rights. It is the hope of the parents and their counsel to offer all students throughout the state the same quality of education and a safe physical space.
